# **Employment History**

I began my career with Salford Royal NHS trust, undertaking rotations in medical rehabilitation, neurological rehabilitation, musculoskeletal out-patients and orthopaedics. There I developed an interest in complex case rehabilitation and began to specialise in mobility and balance rehabilitation both with in patients and in community.

In 2010 I moved to The Alexandra hospital, BMI Healthcare. There I led the discharge planning team for complex neurological, medical, and orthopaedic rehabilitation patients.

Since 2017 I have provided case management as an associate to clients with medium to complex rehabilitation requirements. In addition, from 2018 for 18 months, I also provided rehabilitation consultancy input for a serious injury law firm for clients who did not yet have a case manager. This experience provides me with a strong knowledge of the litigation process and level of requirement expected by a solicitor of a case manager.

Alongside my case management work I continue to work part time in the NHS for Cheshire and Wirral Partnership NHS Trust as a Specialist Mental Health Physiotherapist. I work across 2 inpatients wards, dementia, and acute mental health, assisting patients to maintain and improve their balance and mobility, reduce the risk of falls, increase exercise tolerance, develop motivation to increase activity and support appropriate and timely discharge planning.

Within the trust I am a member of the fall's prevention team and dementia care team.
